Nominations for all open positions must be received by December 23, 2019.

Nominees are requested to provide the Nominations Committee with the following:

- (a) a duly completed Nomination Form;
- (b) a "Consent to Act as a Director" form that is duly signed by the proposed Nominee;
- (c) a resume describing their qualifications for the position for which they are seeking election; and
- (d) a brief statement describing their platform and reasons for being elected to the Board of Directors.

The Nomination Form and "Consent to Act as a Director" Form and Job Descriptions are set forth in the attached link.

Candidates may be nominated for more than one position but may only be elected to one position.

The eligibility requirements to serve as an officer or director of the Club are set forth in Article 5.03 of the Club's By-Laws. Nominees and nominators must be members of the Club in good standing, as defined in Article 5.08 of the Constitution.

Members who are elected to serve on the Board of Directors agree to perform and abide by the duties of each position. Directors MUST act in the best interest of the Club at all times and comply with the Conflict of Interest Policy.

The resume and personal statement of all Nominees will be posted on the web-site to provide members with information concerning the candidates.
